

## Analysis of MSCP Marriage and Family Counseling Practicum-Internship Orientation Evaluation 2016

On May 11, 2016, the annual Practicum-Internship Orientation was held. There were 25 evaluation forms (see attached form) collected from the 25 Marriage and Family Counseling Emphasis student attendees (100% response rate). The students were asked to rate each item on a 1 to 5 Likert scale from Strongly Disagree (1) to Uncertain (3) to Strongly Agree (5). The following results were obtained from a SPSS analysis of the data for each question.

- 1. The orientation was presented in an informative and clear manner.** A total of 25 students answered this item. The average response was 4.52, SD = .653. Two students (8%) answered it "3", 8 students (32%) rated it "4" and 15 students (60%) rated it "5".
- 2. Important points were clearly explained during orientation.** A total of 25 students answered this item. The average response was 4.60, SD = .577. One student (4%) answered it "3", 8 students (32%) rated it "4" and 16 students (64%) rated it "5".
- 3. The number of hours required for Practicum and Internship were clearly stated.** A total of 25 students answered this item. The average score was 4.92, SD = .277. Two students (8%) rated this item "4" and 23 students (92%) rated it "5".
- 4. The difference between administrative and direct contact hours was clearly explained.** A total of 25 students answered this question. The average response was 4.72, SD = .458. Seven students (28%) rated it "4" and 18 students (72%) rated it "5".
- 5. I had the opportunity to ask questions during orientation.** A total of 25 students answered this item. The average response was 4.76, SD = .436. Six students (24%) rated it "4" and 19 students (76%) rated it "5".
- 6. The process of Site Selection was clearly explained during orientation.** A total of 25 students answered this item. The average response was 4.56, SD = .583. One student (4%) rated it "3", 9 students (36%) rated the item "4", and 15 students (60%) rated it "5".
- 7. The requirement to notify the Internship Director if there were ANY problems was clearly stated during orientation.** A total of 25 students answered this item. The average response was 4.80, SD = .408. Five students (20%) rated it "4" and 20 students (80%) rated it "5".
- 8. The requirement of submitting proof of insurance and agency contract for approval PRIOR to starting was clearly stated.** A total of 25 students answered this item. The average response was 4.72, SD = .542. One student (4%) rated it "3", 5 students (20%) rated it "4", and 19 students (76%) rated it "5".

- 9. The roles of Internship Director, Clinical Director, Site Supervisor and Course Instructor were clearly explained.** A total of 25 students answered this item. The average response was 4.72, SD = .458. Seven students (28%) rated it “4” and 18 students (72%) rated it “5”.
- 10. Overall, I am satisfied with the Practicum-Internship Orientation.** A total of 25 students answered this item. The average response was 4.60, SD = .577. One student (4%) rated it “3”, 8 students (32%) rated it “4” and 16 students (64%) rated it “5”.

Ninety-six percent of the students (24 out of 25) either agreed or strongly agreed that they were satisfied with the orientation compared to 100% last year (2015). The majority of the items were answered similarly to last year’s orientation.

The new MF Internship Director was introduced and participated at this meeting and students were asked to direct certain questions to her. She also briefly presented the process of site selection section of the orientation and it was well received (see #6 above). The rating of this item did increase slightly from last year when the former Internship Director was not in attendance. No changes in the content of the orientation are indicated by these data at this time.
