3. Results, conclusions, and discoveries. What are the results of the planned activities listed above? What conclusions or discoveries were made from these results?

<p>Results, conclusions, and discoveries</p>
<p>The curriculum was restructured in 2006-07 as a result of the process of defining assessable program outcomes that began in 2005. Both the major and the general education requirements (both an upper and lower division course) were re-done in this process. Fall 2007 was the first semester cycle for the assessment process, although data is available for previous semesters based on the previous program.</p>

The evidence for student learning in each of the assessed program outcomes is positive, affirming that the curriculum is engaging students appropriately.

4. Use of Results. Did the results lead to program changes? If so, describe the changes made. If not, describe why changes were not needed.

The results reaffirm the developmental links in the curriculum articulated in the discipline restructuring of 2007. More data from a wider array of courses is needed and will be gathered as we begin the next cycle of program assessment which will include the first attempt at the revamped RE 490 seminar.

Cumulative assessment data will be gathered in the RE 490 Senior Seminar and NCEA ACRE Test which gives normed results on catechetical and religious education programs and comparative results for catholic colleges and universities. Administration of the baseline test will be in March 2008.
